WITNESSETH:

That the Grantor, in consideration of the conveyance of other property by Deed of even date, the receipt and sufficiency of which is hereby acknowledged, has exchanged with, transferred and conveyed and by these presents does exchange with and transfer and convey to the Grantee, its successors and assigns, a perpetual easement for the benefit of the Members of the Grantee for use as Common Property for "Community Beach Access", over and across that certain tract of parcel land in Dare County, North Carolina, described as follows:

Being an easement 8 feet in width the center line of which is described as follows: beginning at a point in the northeasterly right-of-way line of Martin Lane at the southernmost corner of Lot 233 as shown on the plat of Sanderling, Phase 6, recorded in Plat Cabinet B at slides 124 and 125 in the Office of the Register of Deeds of Dare County North Carolina, to which plat reference is hereby made; and running thence with southeastern line of said Lot 233 (being a common boundary line with Lot 234 as shown on said plat) north 66° 30" 0' east 410.85 feet to a point, being the northernmost corner of Lot 234 and in the southwest line of the Common Properties fronting on the Atlantic Ocean.

TO HAVE AND TO HOLD the aforesaid easement, together with all privileges and appurtenances thereto belonging, to the Grantee, and its successors and assigns, to its only use and behoof forever; and the Grantor covenants to and with the Grantee and its successors and assigns, that the Grantor is seized of said premises in fee, and has the right to convey the same in fee simple and that the same are free from all encumbrances, and that the Grantor will warrant and defend the said title to the same against the claims of all persons whatsoever.
